SUBJECT: **ASCIP-B 2024-25 Program for Boosters & Foundations**

ASCIP is pleased to continue offering the ASCIP-B program to its members. The program provides general liability coverage for booster clubs, foundations, auxiliary organizations, non-parent and parent-run foundations, and parent-teacher organizations that support members' educational and extracurricular programs.

This policy is separate from the ASCIP Memorandum of Coverage (MOC) since these organizations typically are not controlled by the members and are excluded from the MOC. We recognize these organizations are vital for their fundraising efforts; thus, we continue to offer this program to our members. By providing this program, organizations have a feasible option to procure general liability coverage, and members have peace of mind knowing these organizations maintain liability coverage throughout the year.

Members participating in the ASCIP-B program for the 2023-24 program year will have coverage rolled over for the 2024-25 program year unless you notify ASCIP otherwise. I included a list of organizations as an attachment. **Please note: Each booster or foundation must submit a roster form to secure coverage for the 2024-25 program year.** For your convenience, organizations may complete their roster form online using the QR Code provided below or via the attached PDF.
